

Reprieve US- Postgraduate Fellowships

Application process & award eligibility

Role descriptions for open postgraduate positions will be posted on our website as they become available. Applicants should review and apply for the role(s) they are interested in, submitting documents tailored to each position.

Applications will be accepted on a rolling basis until all fellowship places are filled.

Once applications are reviewed, successful applicants are invited to attend two rounds of online interviews before an offer for a postgraduate fellowship is made. Offers are dependent on successful applications for institutional funding. If an offer is made and accepted we will work with the prospective fellow on their funding applications.

Fellows are expected to attract funding totaling a minimum of \$50,000 through external bodies (e.g. their school). Fellowships cannot be wholly or partially self-funded. Applicants should provide detail on their proposed funding source in their application documents, and it is our preference that applicants apply for school funding.

Location

Fellows will join the Reprieve US team based in Washington DC. The team work on a hybrid basis, working from our office a minimum of 2 days per week. Fellows will work closely with colleagues in other locations.

Fellows should have the right to live and work in the US at the time of application and for the duration of the fellowship. Unfortunately, we are unable to sponsor visas or work permits or to host fellows in locations outside the US.

We hope that fellows will have the opportunity to visit Reprieve's London office during their fellowship year.

Postgraduate Fellow Salary

Our preference is that postgraduate fellowship awards are transferred to Reprieve US for disbursement to fellows, who will join us as staff members and benefit from our healthcare, vision and dental and other benefits. If an awarding body has a policy requiring direct payment to the fellow we are happy to consider this arrangement on a case by case basis.

Reprieve has an open and transparent <u>salary structure</u>, governed by a principle that the highest-paid member of staff is paid no more than double the lowest-paid member of staff. Our postgraduate fellow salary is currently \$56,278. If fellowship funding falls between \$50,000 and \$56,278 we will top up the amount to meet our fixed salary.

Benefits

Reprieve US offers staff a range of benefits including a generous annual leave allowance of 25 days plus federal holidays.

Postgraduate Fellowships

Postgraduate fellows will join one of Reprieve's teams, or work on a multi-disciplinary fellowship across different teams. Each postgraduate fellowship role has a job description which is available on our website.

Each fellow will be assigned a supervisor, who they will meet with frequently. Fellows will work with colleagues across the team and organization on a variety of individual and collaborative topics. For more information on the types of work and tasks that postgraduate fellows can expect to complete, please see the individual job descriptions.
